Information about finding work in Malta

Who is allowed to work?

To work in Malta you must be:

- An EEA citizen (the EU, plus Iceland, Norway and Lichtenstein)
- A Swiss national

If you are from another country, you will need a work permit/employment licence before you can work in Malta.

Where are jobs advertised?

- Local online job boards often carry adverts for jobs in the 'classified ads'.
- Job agencies: Local agencies can be found by searching online
- Job centres: Jobsplus is a reliable government-run centre, their online portal can be found [here](#).

What is a National Insurance (NI) number?

If you're employed, you pay tax on your wages through a system called Pay As You Earn (PAYE). Your employer uses this system to deduct Income Tax and National Insurance contributions from your wages before you are paid. You must have a National Insurance number to work in Malta. It is your own unique, personal account number, and you keep the same one your whole life. It ensures that the National Insurance contributions and tax you pay are properly recorded against your name.

How do I apply for a National Insurance (NI) number?

To apply for a National Insurance number in Malta, you can:

- Apply online: <https://socialsecurity.gov.mt/en/ssnen/> by submitting a signed employment contract and identification document (Passport or ID).
